Fifty Seventh Annual General Meeting of the Equity Shareholders of EICL Limited held at 11.00 A.M. on Tuesday, 17th August, 2021 through Video Conference ('VC')/Other Audio Visual Means (OAVM).

I, V. Viswanathan, Partner, Gopimohan Satheesan & Associates, Practicing Company Secretaries, have been appointed as Scrutinizer for the purpose of scrutinizing the process of voting through electronic means ('e-voting') on the resolutions contained in the notice dated 25th May, 2021 ('notice') issued in accordance with MCA Circular No. 14/2020 dated April 08, 2020 and MCA Circular No. 17/2020 dated April 13, 2020, MCA Circular No. 20/2020 dated May 05, 2020 and MCA Circular No. 2/2021 dated January 13, 2021, respectively issued by the Ministry of Corporate Affairs (MCA), Government of India, calling the 57th AGM of its equity shareholders through VC/OAVM.
